### **DDOT Automatically Extends Specific Permits: Occupancy and Construction Permits Issued Under the Mayoral Health Emergency Extended through 2023**

**Washington, D.C.** – The District Department of Transportation (DDOT) today announced that several permit types issued during Mayor Muriel Bowser’s COVID 19 [state of emergency and public health emergency](#) will be automatically renewed. These permits currently expire **August 31, 2022**, but will be extended automatically in the coming week. **No action is required at this time by permittees.**

Permit types affected, including Occupancy Permits, Other Special Events (Streeteries) and Parklets, will be extended through **December 31, 2023**. Also, Temporary Sidewalk Table Service, Restaurant Curbside Pick-Up Zones, and Non-Essential Retailer Curbside Pick-Up Zones permits will be extended through **May 31, 2023**.

Additionally, Winterization Construction Permits for Tents and/or Heaters and Platforms and/or Walls in Public Space will also be extended under this Mayor’s Order.

Upon the completion of the program enhancement and date conversion in the [Transportation Online Permitting System \(TOPS\)](#), occupancy permittees will need to reprint their new permits with the revised expiration dates now ending either May 31, 2023 or December 31, 2023. New and updated Emergency No Parking/Reserved Parking (ENP/RP) signs will need to be printed out and reposted as permitted. Please ensure you maintain a copy of your approved permit onsite at all times as required by DCMR24 regulations.
