## Suspension of Work in the District of Columbia

### Observance of the Birthday of the Rev. Dr. Martin Luther King Jr. Monday, January 21, 2019

In observance of the birthday of the Rev. Dr. Martin Luther King Jr. and pursuant to section 103.01 Article 17 item C of the District's Standard Specifications for Highways and Structures, there will be a suspension of work in the District at 12 a.m. on Monday, January 21, 2019. **Lane closures and work zones will not be allowed for non-emergency work in roadways, alleys and sidewalks within the District's right of way.** This includes manhole access and construction-related deliveries.

Approved activities may resume Tuesday, January 22, 2019, during permitted work hours.

Per the District Department of Transportation (DDOT)'s standard practice, exemptions will be allowed for cause in limited cases during this suspension of work. Exemptions must be requested by Wednesday, January 9, 2019. Exemption requests must be made in writing to Stacey Collins, Chief of Public Space Inspections, via email [Stacey.Collins@dc.gov](mailto:Stacey.Collins@dc.gov) with the following in the subject line, "2019 Birthday of Dr. Martin Luther King Jr. Exemption Request."

The exemption request must include the following information:

- Public space permit number(s) for the work zone, including construction and occupancy permits
- Location of work zone
- Day(s) and hour(s) for the exemption
- Nature/phase of work taking place during exemption
- Basis/rationale for the exemption
- 24-hour emergency contact name, phone number, and email address
